

India facing Malaysia in BWF World Junior Championship - 2015

The redraw for the Mixed Team Championships of the BWF World Junior Championships 2015 was conducted in the BWF office in Kuala Lumpur today.

Forty (40) Teams have been divided into four Groups, each consisting of two Sub-Groups. Each Sub-Group will have round-robin matches; the two Sub-Group winners of each Group will then face each other for the right to enter the Semi-Finals. The other Teams will fight for placing. The runners-up of each Group will vie for places 5-8; the third-placed Teams for places 9-12, and so on.



In today's redraw, the places of the 16 seeded Teams from the original draw were retained; the remaining 24 Teams (ranked 17 to 40) and their respective sub-groups were picked by lots. **The redraw saw defending Champions China placed with Canada, Italy, Turkey and Mexico in sub-group A1, while Malaysia and India in sub-group A2 were drawn alongside USA, Zambia and El Salvador.**

The Team event will be held from 4 to 8 November, followed by the Individual event from 10 to 15 November in Lima, Peru.
