This letter is in continuation to my previous letter dated 23.06.2011 whereby I had informed you that Dr. Akhilesh Das Gupta stands duly elected unopposed as the President of Badminton Association of India. Through the said letter it was also informed that polling for the post of Hony. Treasurer, BAI shall be taken from 11:00 am to 1:00 pm on 2^{nt} July 2011 at the place where the AGM of BAI is to be held.

Now this is to inform you that poll for the post of Hony. Treasurer, BAI was conducted on 02.07.2011 as per the schedule declared by the undersigned, in the presence of the Govt. of India observer Sri S. K. Mendiratta and Indian Olympic Association's observer Sri Rakesh Gupta.

First of all the result for the post of the President of the Badminton Association of India was declared and Dr. Akhilesh Das Gupta was declared as duly elected President of the Badminton Association of India. Thereafter before opening the polls for the post of Hony. Treasurer, BAI the ballot box was opened and shown to all the voters / delegates present in the AGM and thereafter locked and sealed in front of everyone and kept for dropping the ballot papers. Before polling for the post of the Hony. Treasurer, Badminton Association of India could begun, one of the candidates, Sri Krishna Nand Jaiswal (Bihar) retired in favour of Sri Ashok Bajaj. He also gave a formal letter in writing in this regard, which has been made a part of records of this election.

In the polling of the election for the post of the Hony. Treasurer of the Association in total 54 votes were casted. These votes were casted in about half time of the polling. Thereafter an announcement was made to the effect that if anyone present in the AGM hall was left from voting. The response was no but we waited till the scheduled time of closing of polls i.e. 1:00 pm.

Immediately thereafter both the contesting candidates Sri Ashok Bajaj and Sri Vinaya K. Aggarwal were asked to come near the table of the Returning Officer where the ballot box was kept. The seal of the ballot box was opened in the AGM hall itself in presence of both the candidates as well as all the representatives / voters present in the AGM. The ballot papers were taken out. There were 54 ballot papers in the ballot box. During the counting of the votes, no vote was found invalid. At the time of counting of votes Sri Vinaya K. Aggarwal was present throughout. Sri Krishna Nand Jaiswal did not get any vote, Sri Vinaya K. Aggarwal got 9 votes whereas Sri Ashok Bajaj secured 45 votes. The result of counting was announced then and there.
